CONSERVATIVE FIGHTER FUND NOTICE

CONSERVATIVE FIGHTER FUND is a joint fundraising committee composed of MORRISEY FOR SENATE, INC. and WEST VIRGINIA REPUBLICAN PARTY, INC.

Any contribution to CONSERVATIVE FIGHTER FUND permissible under the Federal Election Campaign Act, as amended, from contributors who have not exceeded their applicable contribution limits will be allocated among the participating committees as follows:

- a. The first \$2,700 from an individual shall be allocated to MORRISEY FOR SENATE, INC., to the maximum permitted to retire the 2018 Primary Election debt. The second \$2,700 shall be allocated to MORRISEY FOR SENATE, INC., for the 2018 General Election. Any remaining funds up to \$10,000 shall be allocated to the WEST VIRGINIA REPUBLICAN PARTY, INC.
- b. The first \$2,700 from a federal non-multicandidate committee shall be allocated to MORRISEY FOR SENATE, INC., to the maximum permitted to retire the 2018 Primary Election debt. The second \$2,700 shall be allocated to MORRISEY FOR SENATE, INC., for the 2018 General Election. Any remaining funds up to \$10,000 shall be allocated to the WEST VIRGINIA REPUBLICAN PARTY, INC.
- c. The first \$5,000 from a federal multicandidate committee shall be allocated MORRISEY FOR SENATE, INC., to the maximum permitted to retire the 2018 Primary Election debt. The second \$5,000 shall be allocated to MORRISEY FOR SENATE, INC., for the 2018 General Election. Any remaining funds up to \$5,000 shall be allocated to WEST VIRGINIA REPUBLICAN PARTY, INC.

The contributor's signature designates his or her contribution as described above. Contributions that exceed a contributor's contribution limit to a participating committee shall be reallocated to the remaining participating committees according to this allocation formula and as permitted by law. The allocation formula may change if MORRISEY FOR SENATE, INC., receives enough funds to pay its Primary debts.

All funds received in response to this solicitation will be subject to federal contribution limits and prohibitions. Contributions from corporations, national banks, labor unions, foreign nationals without "green cards," and federal government contractors are prohibited. Contributions to CONSERVATIVE FIGHTER FUND, or any participating committee, are not deductible as charitable contributions for federal income tax purposes. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation, and employer of each individual who contributes over \$200 in a calendar year.

Contributions to Conservative Fighter Fund are not deductible as charitable contributions for federal income tax purposes. Contributions from corporations, foreign nations, and federal government contractors. Notwithstanding the allocation formula, contributions may be designated by the contributor for a specific committee, to the extent permitted by law.

Miller Victory Fund Fundraising Notice

Miller Victory Fund ("JFC") is a joint fundraising committee composed of Carol for Congress, West Virginia Republican Party, Inc. (Federal Account), and NRCC (each, a "Committee," and, collectively, the "Committees"). Any contribution to the JFC permissible under the Federal Election Campaign Act, as amended ("FECA"), from contributors who have not exceeded their applicable Federal contribution limits, shall be allocated among the Committees pursuant to FECA and the formula set forth in this Notice.

Contributions Made by an Individual or Federal Non-Multicandidate Political Committee:

Individuals or federal non-multicandidate PACs may contribute up to \$252,700 annually. Such contributions shall be allocated in the following order:

1. Carol for Congress shall receive any contribution not exceeding \$5,400, designating up to \$2,700 to the primary election and up to \$2,700 to the general election, provided such limits apply.
2. West Virginia Republican Party, Inc., shall receive for its federal account any contribution not exceeding \$10,000 annually.
3. NRCC shall receive for its general account any contribution not exceeding \$33,900 annually.
4. NRCC shall receive for its Building Fund any contribution not exceeding \$101,700 annually.
5. NRCC shall receive for its Legal Proceedings Fund any contribution not exceeding \$101,700 annually.

Contributions Made by a Federal Multicandidate Political Committee:

Multicandidate PACs may contribute up to \$120,000 annually. Such contributions shall be allocated in the following order:

1. Carol for Congress shall receive any contribution not exceeding \$10,000, designating up to \$5,000 to the primary election and up to \$5,000 to the general election, provided such limits apply.
2. West Virginia Republican Party, Inc., shall receive for its federal account any contribution not exceeding \$5,000 annually.
3. NRCC shall receive for its general account any contribution not exceeding \$15,000 annually.
4. NRCC shall receive for its Building Fund any contribution not exceeding \$45,000 annually.
5. NRCC shall receive for its Legal Proceedings Fund any contribution not exceeding \$45,000 annually.

Contributions to Miller Victory Fund, or to any participating Committee individually, are not deductible as charitable donations for federal income tax purposes. Contributions from corporations, labor organizations, national banks, federal government contractors, foreign nationals without green cards, and other federally impermissible sources are prohibited. The contributor's signature designates his or her contribution to the elections described above. Contributions that exceed a donor's contribution limit to a participating Committee shall be reallocated to the remaining Committees according to this allocation formula to the extent permitted by FECA. Any contributor may designate his or her contribution to a specific participating Committee to the extent permissible by FECA. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation, and name of employer of each individual whose aggregate contributions exceed \$200 in an election cycle or calendar year, as applicable.
